

## **FULFILLING OF REPORTING OBLIGATIONS PURSUANT TO ART. 13 GDPR**

Whereas ISOTRA a. s., ID No. 47679191, registered office: Bílovecká 2411/1, Předměstí, CZ-74601 Opava, Czech Republic, entered in the Commercial Register maintained by the Regional Court in Ostrava, under reference B/3169 (hereinafter "ISOTRA" or the "Controller"), processes personal data as a controller in terms of the General Data Protection Regulation<sup>1</sup> (hereinafter "GDPR"), and assumes the position of a personal data controller for most activities. Exceptionally, ISOTRA may also be in a position of a personal data processor.

Protection and safeguarding of personal data processed is a priority for ISOTRA, therefore ISOTRA pays appropriate attention to personal data and their protection. On those grounds, ISOTRA hereby informs data subjects on the personal data processing implemented and on the rights of data subjects in relation to the processing of their personal data. The Controller adds to the aforementioned information that personal data are only processed for a period necessary to attain the aforementioned objectives and they are only passed to recipients in the minimum extent necessary for fulfilling the specified purposes.

If your personal data are processed based on legal grounds of the Controller's legitimate interest [Art. 6, Subpar. 1, Point (f) GDPR], said legitimate interest is due fulfilment of duties under contracts concluded by and between the Controller, business partners, customers, or other entities, exercise of legal claims by the Controller, and exercise of activities within the Controller's object of business. The closed-circuit television (CCTV) system is utilised by the Controller in its premises for the purposes of protection of individuals and assets within the Controller's premises. Monitoring and recording of customers in relation to their payment behaviour is implemented for the purposes of protection of the Controller's financial interests and prevention of concluding contracts with entities that had previously failed to meet their obligations.

The Controller hereby informs the data subjects about their right to demand, under conditions set in Art. 15 through Art. 20 GDPR, access to personal data processed, rectification of personal data processed, erasure of personal data processed, restriction of the processing of personal data processed, and portability of personal data processed.

The Controller hereby informs the data subjects about their right to object, under conditions set in Art. 21 GDPR, to the processing of their personal data.

The aforementioned rights and objections are to be exercised by the complainant in a written documentary form (request with officially verified signature) or electronic form (e-mail message with a recognised electronic signature or a data box message) sent to the contact address(es) of the Controller as mentioned above.

If you believe the processing of your personal data is in breach with GDPR, you are entitled to file a complaint with the respective data protection authority.
